# **BONDS RETIRED FOR MONTGOMERY COUNTY RESOURCE RECOVERY PROJECT** *An Annual Savings of \$25 Million*



he bonds used to finance the development and construction of the Montgomery County Resource

Recovery Project have been paid off. In 1993, the Authority sold \$360 Million in tax-exempt and taxable Solid Waste Revenue Bonds for the construction and equipping of the project. After the bonds were refinanced on several occasions to save the County money while not extending the term, the bonds were finally retired on April 1, 2016.

The retirement of the bonds will reduce the County's cost of processing waste through the transfer station and Resource Recovery Facility by approximately \$25 Million annually. Meanwhile, the award-winning facility will continue to process nearly 600,000 tons of the County's trash on a yearly basis for the foreseeable future while producing enough electricity for 40,000 residents.

### HARFORD WASTE-TO-ENERGY FACILITY CLOSES AFTER 28 YEARS OF OPERATION



he Harford Waste-to-Energy Facility processed its last ton of trash on March 17. During its 28 years of operation, the facility

processed more than 3.5 million tons of solid waste from Harford and Baltimore Counties and produced more than 13 billion pounds of steam for the US Army. The Authority developed the facility in partnership with Harford County and the Army in order to help Harford County reduce the amount of trash it sent to the landfill, as well as provide energy for the Army. It is located on property leased from the Aberdeen Proving Grounds, Edgewood area.

The original facility was built in 1987 by owner and operator WEP/Brambles. In 2002, the Authority purchased the WTE facility for Harford County. At the time of purchase, the Authority extended the steam purchase agreement with the US Army to 2016. Continuing the steam agreement provided cost relief for the Army and helped the Authority pay for the purchase of the facility.

Upon purchase, ENSCO/Brambles continued operations for another year then assigned the operations to Energy Recovery Operations, Inc. (EROI). EROI was founded by the facility manager, who retained the original employees, which provided for a smooth transition and retained operating expertise. EROI continued facility operations through the March closure, always with an eye towards efficient operations, cost minimization and a focus on safety.

Chris Skaggs, Executive Director NMWDA The facility underwent a major environmental control upgrade in 2005, adding acid gas scrubbers and improving the particulate removal system. A carbon injection system that helped to remove mercury, dioxin and furan emissions was also added.

The Authority is presently decommissioning the facility and planning for its demolition in order to restore the Army property prior to closing out the lease. ## **AUTHORITY HELPING TO CONSTRUCT BUILDING FOR PAPER PROCESSING**



he Authority, in conjunction with Maryland Environmental Service (MES), is working with the Montgomery County Department of Environmental Protection, Solid

Waste Services to construct a building at the Montgomery County Recycling Center in Derwood, MD (MRF) to process and store recycled paper at the site. MES is the operator of the MRF on this project. The Authority conducted a procurement and selected Baltimore Contractors, Inc.



(BCI) to design and build an enclosed structure that will house paper recycling machinery along with room for storage of bales from the process. MES has contracted with CP Manufacturing of San Diego, CA, to design, build and install the equipment that will take waste paper and allow MES to sort and bale it for recycling and resale. BCI will be constructing a nearly 10,000 square feet steel building suitable for housing this equipment. The Authority and BCI have coordinated with MES and CP, as well as the County, to insure that the building provides the necessary requirements for the operation of the equipment and storage of the baled paper.
