RE: ADDENDUM #4 FOR THE REQUEST FOR QUALIFICATIONS FOR CONSTRUCTION SERVICES FOR THE GUDE
LANDFILL REMEDIATION PROJECT

The Northeast Maryland Waste Disposal Authority (the "Authority"), a multi-jurisdictional agency, is requesting qualifications submissions from remediation construction contractor firms or construction contractor teams (the "Construction Contractor" or "Offeror"). The Offeror should be qualified to provide the remediation construction services required by the Maryland Department of the Environment ("MDE") approved Corrective Measures for the closed Gude Landfill, in Montgomery County, Maryland. Please send all project related communications to procurement@nmwda.org.

The following questions have been submitted to the Authority:

- 1) PDF Exhibit 3-1 and 3-2 contain duplicate pages 1-7. In what section do we put the first seven pages?
 - A. *Please include pages 1 through 7 in the response on Exhibit 3-1.*
- 2) Exhibit 3-3 TOTAL RATING note appears to be incorrect and may confuse some references when adding up total. i.e. Excellent will only score 50 points.
 - A. *Thank you for addressing this issue. The Authority is revising the scoring on the Exhibit 3-3 Project-Reference-Form to reflect a maximum value per reference as 50 points, with the minimum score at 25 points to qualify as acceptable. Please note that the forms indicate that the completed references are to be submitted no later than November 20, 2020.*

The Authority is revising Section 5.3 of the RFQ to the following:

The Offeror shall complete the required information regarding references on Exhibit 3-2 (the Representative Projects Form) as well as Exhibit 3-3 (the Representative Project Information and Reference Form) for each representative project and submit under this ~~RFP~~-RFQ. *There should be a minimum of 5 projects and a maximum of 10 projects.* References must include a contact name, company name, current address, current phone number, and e-mail on Exhibit 3-3. References and current contacts must be verified by the Offeror within the preceding three (3) weeks prior to submission to the Authority under this RFQ. Please see Section 1.6 herein for submission directions.
