BALTIMORE COUNTY IMPLEMENTING UPDATES TO SOLID WASTE REGULATIONS

altimore County released the Final Report of the **Baltimore County Solid** Waste Work Group on September 14 and at the same time began implementing some of the recommended updates to the County's solid waste regulations. The mission of the Work Group was to examine current operations of the Bureau of Solid Waste and to study the state of waste materials management regionally, nationally and globally. Facilitated discussions with stakeholders were held in an effort to generate actionable steps for the County to take during a five-year planning period. The Authority, through staff participation and the use of its on-call consulting contracts, assisted the County in developing the scope of this study to ensure that the final product would meet the County's expectations. This planning effort reflects one of the many facets of the Authority's mission of service to its Members.

The Work Group's mission began in October 2020 when Baltimore County Executive Johnny Olszewski issued an

Executive Order stating that "the work group will examine existing efforts as well as national best practices, and will make recommendations that will inform a five-year plan for improving the county's solid waste collection and disposal system. This will include recommendations related to improving the operations of waste collection and improving internal Department of Public Works (DPW) operations, as well as recommendations for reducing overall waste production by promoting improved recycling practices, composting and other innovative waste diversion strategies. The County will partner with the Northeast Maryland Waste Disposal Authority to facilitate the work group's efforts and GBB Solid Waste Consultants to provide technical support."

The Work Group, which began meeting in November of 2020, was led by Chief County Administrative Officer Stacy Rogers and was staffed with County personnel from the Department of Public Works and Transportation, the Office of Law, the Department of Environmental Protection and

Sustainability, and the Office of Budget and Finance. Background preparation moved quickly through the Fall as the scope of work was shaped.

The Work Group's task was supported by a break-out subcommittee of stakeholders who took a deeper dive into the nuts and bolts of current collections in the County, and discussed how the potential recommendations would impact small businesses. At the same time and equally important, collections companies were able to provide feedback as to how the potential recommendations would impact the day-to-day work of waste haulers. Topics for the Work Group included an analysis of the strengths and weaknesses of current operations, technology research and presentations, and financing options. The February 2021 meeting included a summary of a public survey that had been conducted for the purpose of allowing residents and businesses in Baltimore County to weigh in on solid waste topics.

The final meeting was on March 4 and included a presentation of the potential recommendations and a public comment period. GBB provided a budget analysis of the potential recommendations so that the County would be able to make practical planning decisions moving forward. As a result of these efforts, the County is moving forward with several of the policy and practical recommendations for FY 22, including certain updates to the County's collections regulations and procurement of bulk waste collections services.

Throughout its process, the Work Group was guided by the following questions:

- How to prevent, reduce, reuse?
- What to recycle/divert?
- How to collect and process?
- What to do with what is left?
- How to finance?

Additionally, the Solid Waste Work Group defined the three pillars of the Zero Waste concept for the County as follows:

- 1. Reduction and reuse of materials, e.g., Extended Producer Responsibility (EPR)/ Product Stewardship (also to increase recycling), food capture and distribution, bulky material collection for reuse/donation, promotion of refill and reuse packaging models at stores;
- **2.** Increased recycling, e.g., current curbside materials such as food scraps, mattresses, electronics and paint; and
- **3.** Use of a sustainability lens for what is left.

In announcing the release of the Final Report, County Executive Olszewski said, "I applaud County Administrative Officer Rodgers and all the members of our Work Group for their efforts to develop these actionable recommendations which will inform our ongoing work to create more sustainable practices, reduce the garbage we create, and protect our planet."

The City has been working for months to distribute the recycling carts. Through Authority staff participation and its on-call contract with Geosyntec Consultants, the Authority assists the City in tracking data related to the cart roll-out. Geosyntec worked with the City to develop the Less Waste, Better Baltimore Plan. The goal of the data monitoring effort is to support the City's tracking and reporting efforts in order to provide timely information to residents and elected officials. This includes tracking cart program calls to the City's 311 Center.

Cart manufacturer Rehrig Pacific prepared distribution routes and coordinated delivery teams as part of the project. Carts are being shipped to the City from a manufacturing center throughout the roll-out period and then staged at a City controlled lot. From there, distribution teams load smaller

box trucks each day for delivery. For more information on cart distribution visit:
